What we accept- D's Home Again (DHA) welcomes your quality used furniture, antiques, home décor pieces, textiles, accessories and collectibles. Up to 20 items per consignor, per month. We do not accept broken items or electronics. ***Please clean your items, not just dust, before bringing them in to consign.*** Items must be clean, scent free and in usable condition. We offer cleaning of your items at \$40- per hour with a 30 minute minimum. ***Any items brought in, in need of cleaning, will be charged a minimum of \$20.***

Commission – The sale price of consigned items will be split between DHA and the consignor/s as follows; Items priced at \$15.00 or less, consignor receives 40% of the sale price. Items priced \$16.00 to \$300.00 consignor receives 50% of the sale price. Items priced \$301.00 or more, consignor receives 60% of the sale price. Other amounts that may be outstanding such as; pick up, delivery, cleaning, repair, online listing fees, shipping and handling, and insurance charges will also be deducted from the consignor's proceeds unless otherwise stated.

Pricing & Pick-up– Pricing of all consigned items will be set by DHA and Consignor. Prices will be reduced by 10% after 30 days, 25% after 60 days, and 50% after 90 days. Merchandise not sold after 120 days (4 months) must be picked up by consignor within 15 days or will become the property of D's Home Again. Seasonal/holiday items must be picked up within 15 days of holiday or end of season. DHA reserves the right to adjust prices at any time as deemed necessary never going below set reserve price. ***Reserve prices (minimum sell price) may be set by consignor and are subject to a maintenance fee of 10% if not sold.***

Liability – Consignor hereby confirms and agrees that in the event of damage or theft of the property, D's Home Again's liability shall in no event exceed 50% of the original assigned price or the reserve price minus set %. D's Home Again will not be held liable for damage or loss not covered by insurance.

Payment – Checks are written monthly for the previous months sold items. If the balance due is \$10.00 or more, checks will be available for pickup the first store business day after 15th of each month. Smaller amounts can be converted to store credit or combined with the following month's payment. ***Mailing of checks will be available for a fee of .65 cents.*** A request for a mailed check must be made by the 10th of the month. Lost checks are subject to a stop payment fee. Rewriting checks are subject to a \$2.00 fee. ***Outstanding fees such as cleaning, pick-up and/or home consulting fees will be deducted from your payment.***

Early Removal- ***Consignor agrees to leave merchandise to be displayed at D's Home Again for a minimum of 2 months. Items removed before that time will be subject to a storage/handling fee of 5% or \$10.00, whichever is more.***
